

SAFe® Templates: Release Update Log

Last Update: April 30, 2023

Overview

The purpose of this document is to articulate the set of fixes and enhancements made to the SAFe product templates release-to-release, starting with the delivery of the SAFe 3.0 Program process template delivered in Rational Team Concert (RTC) 6.0. Since that release, the following templates have been delivered:

- SAFe 3.0 Portfolio templates in Collaborative Lifecycle Management (CLM) 6.0.1
- SAFe 4.0 templates in Collaborative Lifecycle Management (CLM) 6.0.3
- SAFe 4.5 templates in Collaborative Lifecycle Management (CLM) 6.0.6
- SAFe 4.6 templates in Engineering Lifecycle Management (ELM) 7.0
- *SAFe 5.0 templates* in Engineering Lifecycle Management (ELM) 7.0.1
- *SAFe 6.0 templates for* Engineering Lifecycle Management (ELM) 7.0.2

This is a living document that will be updated with each release of the templates.

Product Renaming (7.0)

As of 7.0, the products have been renamed:

- Collaborative Lifecycle Management → Engineering Lifecycle Management (ELM) base
- Rational Team Concert → Engineering Workflow Management (EWM)
- Rational DOORS Next Generation → Engineering DOORS Next Generation (DOORS Next)
- Rational Quality Manager → Engineering Test Management (ETM)

Work Item Updates

- Added **Type Description** hyperlink on all work item types to embed process guidance
- Enabled **Blocked** and **Reason** attributes to “soft block” a work item in Kanban and Taskboard plans

Task

- Fixed workflow state IDs that were duplicates of those for the *Defect* work item type

PI Objective

- **Achieved Value** attribute added along with a custom calculation *Achieved Value Provider*: $\%$
achieved value = value (actual) / value (planned) * 100

Risk

- *Exposure Provider* custom calculation added
- Added the **Occurrence Date** attribute to the work item editor
- Added workflow icon

Story

- Updated the *Story* workflow to allow transition from In Progress to Invalid
- Added icons for workflow actions

Feature

- Added **Acceptance Criteria** to the *Feature* work item type
- Updated the *Feature* workflow to allow transition from Invalid to New

Plan/Query Updates

- A new query was added to show the post-project initialization tasks: **Post-Project Initialization Tasks**
- Default WIP limits added to Kanban views
- Updated card configurations to include new attributes:
 - a. Medium Card: Summary, Owned By, Planned For, WSJF, Contribute To link
 - b. Large Card: Summary, Owned By, Planned For, WSJF, Contributes To link, WSJF components
- Created a new **Architectural Runway** play view

- Added **ART Iteration** type definition
- Updated permissions for Team Member and Product Owner:
 - a. Team Member: Removed Delete Plan and Delete Plan Snapshot permissions
